#### **Operations**

- The plant continues to operate in CEPT mode.
- We scheduled a digester review meeting with Tim Steed, of Hunt Engineers, the last week in May to discuss evaluation of digesters 1 and 2.
- Digester #1: WeCare Organics is still two weeks from having the digester empty. They have run into trouble pumping and dewatering due to the high media volume in the sludge. As soon as WeCare is done with the sludge removal, Blue Heron will be in to remove the remaining cables from the compression ring in order to give Hunt better access to the inside of the tank. Hunt has determined the compression ring unsound from their initial assessment, they will get right into the tank and begin sounding the walls to check structural integrity. If any voids or deficiencies are found, core sampling will begin with special care taken to not disrupt the pre-tensioned cable cast into the concrete.

Digester #2: When Blue Heron comes in to remove the remaining cables from digester #1, they will remove the cover from digester #2 at the same time. Once that is done WeCare can then begin to empty digester #2.

Digester #3: Spensieri has finished all patchwork and sealing and we will begin filling the tank Wednesday morning to check for leaks.

- Renovation and repair work on the North Bar Screen is in progress
- Microbac Laboratories came today and collected 6 air samples for fungal spore analysis
   5 in the lower levels of the BAF and 1 outside for a baseline comparison

# **Other**

- It has been brought to my attention by the US Attorney handling the case against Crane
  Hogan that the City of Binghamton Rules and Regulations do not match the plant Rules
  and Regulations. I have been strongly advised to get this corrected.
- Work on the modular office building continues with Modspace, The building and grading work is in progress.
- Binghamton Fire Department has scheduled a confined space exercise at the "dog house" over the E. primary pump building(#7). They have had several teams complete training thus far.

## **Committee Reports**

- Operations George Kolba, Jr. reported on the status of his research for a cost study regarding purchase of an additional dump truck for sludge disposal. He recommends that a truck with an automatic transmission be purchased, with extended warranty and a tire bank. Additional research will be done to compare a leasing approach.
- Finance Edward Crumb reported that the Committee is looking at the possibility of procuring natural gas supply via the Municipal Gas and Electric Alliance (MEGA) through which our electric supply is purchased. A discussion took place regarding time and material contracts. Gary Holmes will research the term contracts the City has in place that the Board can piggy-back off of. The 2015 Budget preparation was discussed and approved with date adjustments. The Superintendent's budget requests will be due to the Board June 25<sup>th</sup>.
- Personnel Stephen Andrew reported that, regarding the Union's proposal for a travel and training policy, the per diem approach is favored. This will be researched by the new Business Manager.

Ad Hoc – Ron Davis stated that he had nothing to report.

Flow Management Workgroup – the following motions were made and acted on:

Edward Crumb made a motion for the Board to approve that, effective upon employment, Business Manager Charles Pearsall will become the Bank Administrator for the I/I Offset Bank under the Flow Management Plan.

George Kolba, Jr. seconded the motion Motion carried 6/0

Eugene Hulbert, Sr. made a motion for the Board to award Broome Community College the full 23,492 I/I Offset Credits they are requesting upon receiving a signed report from a Professional Engineer.

Gary Holmes seconded the motion Motion carried 6/0

Structure and Flood – Eugene Hulbert, Sr. reported that, based on discussions with Howard Weaver, the Board does not owe money for the 2006 flood. Instead, FEMA owes the Board additional funds and Simmons Recovery continues to work on this matter with the NYSDHES and FEMA personnel now assigned to this matter. Mr. Hulbert would like to schedule an update meeting with Simmons in early June.

George Kolba, Jr. made a motion for the Board to authorize the FEMA Claim Consultant (Simmons Recovery) to submit an additional scope request to the New York State Department of Homeland Security and Emergency Services for the Digester Complex based on the May 14, 2014 email from Howard Weaver of Simmons for reimburse for removal of the sludge in Digester Nos. 1 and 2, replacement of flood-damaged bubble guns, removal, temporary storage and putting the covers back on the digesters.

Ronald Davis seconded the motion

Motion carried 6/0

## Correspondence

GHD's monthly report for the Industrial Wastewater Pretreatment Program was noted.

Superintendent Young noted that GHD is "inching along" in terms of finalizing the plans and specifications for the Digester Complex Renovation Project.

Johnson City Resolution 14-62 approving IMA-X was noted.

Co-Counsel Perticone's April 30, 2014 letter to the Town of Kirkwood replying to its April 11, 2014 letter regarding its CMOM Program was noted.

George Kolba, Jr. made a motion for the Board to send John Perticone, Esq.'s letter to the permittees under the IWWPP with significant violations during the prior pretreatment program year.
