Re: Award of Contract
Liquid Cationic Polyacrylamide Derivative Used as a Flocculent to Improve
Solids Removal (Clarifloc NE-2547)

Dear Sir/Madam:

At a meeting of the Binghamton-Johnson City Joint Sewage Board (“the Board”) on January 18, 2024, the Board authorized me to forward to your company this letter agreement. In accordance with New York General Municipal Law § 103, subdivisions 3 and 16 (“the Piggyback Statutes”), your company agrees to sell to the Board and the Board agrees to purchase from your company the Product identified above, through the use of a contract let to your company by the County of Oneida, New York (“the County”). Your company was determined by the County to be the lowest responsible bidder responding to a “Request for Bid for Polymer to Thicken and Dewater Sludge at the Oneida County Department of Water Quality & Water Pollution Control Wastewater Treatment Plant” (hereafter “Request to Bid”), identified as Bid Reference No. 2258, and published by the County on or about October 24, 2023.

Your company agrees to sell the Product to the Board upon the terms set forth in the Request to Bid, and in accordance with the Polymer Bid Sheet dated November 6, 2023, which your company submitted to the County in response to the County’s Request to Bid. Both the Request to Bid and the Polymer Bid Sheet are incorporated herein, except for those terms which are unique to the County; as for those terms, the Board shall be substituted for the County.

Among other terms incorporated herein, your company agrees to sell the Product to the Board at a unit price of \$1.31/Lb., including all shipping, handling and delivery charges to the Binghamton-Johnson City Joint Sewage Treatment Plant, 4480 Vestal Road, Vestal, NY (“the Plant”). The term of the agreement shall be one year, effective January 1, 2024, with price adjustments and term renewals as set forth in the Request to Bid. The Board shall not authorize delivery of the Product to the Plant until certificates evidencing insurance required by the Request to Bid are delivered to the Board. The Board, The City of Binghamton, New York and the Village of Johnson City, New York shall be included as additional insureds on those policies of insurance identified in the Request for Bid as requiring that the County be so included.

Written notices to the Board shall be addressed to 4480 Vestal Road, Vestal, NY 13850. The Project Manager for the Board shall be the Plant Superintendent, currently Elliott Wagner.

If your company is in agreement with the terms hereof, please have an authorized representative of your company execute and date this letter agreement in the spaces provided

below, and then return the original to the Board. A copy of this letter agreement is enclosed for your records.
